# LAST CHANCE COMMUNITY POW WOW VENDOR RULES AND POLICIES (2024)

## GENERAL RULES:

1. No food vendors or sales of food will be allowed, including, but not limited to, candy, snacks, and gum.
2. Vendors may be asked to put away and stop selling any item(s) deemed to be dangerous or inappropriate. Refusal or second offense will result in the vendor being escorted off the premises and they will not be allowed to return as a vendor. No refund of fees will be made under these circumstances.
3. No toys of any kind will be allowed to be sold.
4. Stapling or nailing is allowed only on display panels, never directly on the walls.
5. All displays or booths must be free-standing, self-supporting, and shall not be secured to walls, floor, or ceiling.
6. Pow Wow Committee members and/or Lewis & Clark County Fairgrounds employees retain the right to take appropriate action, including removal from the premises, for violation of these rules or for any other situation or action that they deem inappropriate or dangerous.

## VENDOR PRE-REGISTRATION:

To better plan and utilize the vendor space, we are asking all vendors to pay their fees at the time they send in the completed Vendor Application. Only those vendors who are prepaid will be guaranteed a space. Other vendors will be assigned the remaining spaces on a "first come, first serve" basis, but only IF a COMPLETED APPLICATION is received PRIOR to the pow wow

## REFUNDS:

1. Refund of fees will be made **IF** cancellation is made on or before September 24, 2024.
2. Cancellation after September 24<sup>th</sup> will be made **IF** we are able to rent the space to another vendor or by special consideration of the circumstances.
